ORDER

This Commission vide Order dated 22-9-2009 had asked for a compliance report on the following directions viz.,

- (1) The Respondent-PIO to furnish the required information to the appellant i.e. information asked by him through the R.T.I. application dated 12-3-2009, within 30 days time' free of cost.
- (2) The concerned Public Authority of M.C.A.B., to notify the requisite functionaries under the R.T.I., if not already done.
- (3) The Nodal Department viz., Cooperation Department, Govt. of Meghalaya to ensure that other Cooperative Societies who qualify for being notified as public authorities under the Law should designate all appropriate functionaries under the Law, with intimation to this Commission.

As per report received in the Commission it appears that the requirement to notify the requisite functionary under the R.T.I. Act has been complied with by M.C.A.B.. However, the appellant informed this Commission that the information furnished by the Branch Manager & P.I.O., MCAB, does not comply with the requirement as per the original R.T.I. application dated 12-3-2009.

Let a copy of the above complaint dated 21-10-2009 be furnished to the Branch Manager & PIO, MCAB, immediately and the Respondent-PIO is allowed 20 days time to furnish the correct information with intimation to this Commission. Meanwhile, the Commission noted that the Nodal Department viz., the

Department of Cooperation, Meghalaya has not furnished any report of action taken by it in compliance of the direction given by the Commission.
