ORDER

Perused complaint petition dated 12th August, 2009 received from the complainant, Shri S.K.Singh, Barapathar, Shillong.

The case of the complainant is that he had filed an R.T.I. application vide letter No. 1108/SKS/School/RTI-05/09-08 dated 6-7-2009 before the Respondent-PIO and Headmaster, Madan Laban Nepali Secondary School, Shillong. Vide his above application he requested the P.I.O. to supply the detail information as per the School (A/Cs) records regarding the actual amount received by the school in the form of grant-in-aids from the Govt. for the financial year ending 2003-04-05 & 06 section-wise including Science Teachers grants; the name of the Bank through which the grants-in-aid are withdrawn/operated along with the Bank Accounts Nos. and copies of authority letter issued by the Managing Committee to the Bank authorizing the member to operate such Bank Accounts. According to the complainant, he had wanted only the amount not the sanction orders whereas the Respondent-PIO has furnished the sanction orders resulting to unnecessary cost for copies paid by him. According to the complainant, such action on the part of the P.I.O. amounts to incorrect/misleading information supplied. Hence this complaint before the Commission.

The Commission examined the copy of original R.T.I. application vide letter No. 1108/SKS/School/RTI-05/09-08 dated 6-7-2009 and found that the complainant has requested for supply of the detail information as per school's records regarding the amounts receipt by the school in the form of grants-in-aid from the Govt. for the financial year ending 2003-04-05 & 06 including Science Teachers grants-in-aid etc. The complainant had not asked for the amount of grants-in-aid

only, but the detail information of such grants-in-aid as per school's records. The information furnished by the Respondent-PIO viz., the sanction orders of grants-in-aid including Science Teachers grant received from the Govt. provides detail information on such amount as per school's records. Therefore, the complainant by asserting that he had requested only the amounts of such grants-in-aid and not the details thereof had only contradicted his own original R.T.I. application. That being the case, the Commission finds no merit in the complaint which is therefore rejected.
