FOREWARD

Under Section 25 of the Right to Information Act, it is the duty of the State Information Commission to prepare an Annual Report on implementation of the provisions of the Act during the year and to submit the same to the appropriate Government for laying it before the State Legislature. Such report shall state, in respect of the year to which it relates, –

- (a) the number of requests made to each public authority;
- (b) the number of decisions where applicants were not entitled to access to the documents pursuant to the requests, the provisions of this Act under which these decisions were made and the number of times such provisions were invoked;
- (c) the number of appeals referred to the State Information Commission, for review, the nature of the appeals and the outcome of the appeals;
- (d) particulars of any disciplinary action taken against any officer in respect of the administration of this Act;
- (e) the amount of charges collected by each public authority under this act;
- (f) any facts which indicates an effort by the public authorities to administer and implement the spirit and intention of this Act;
- (g) recommendations for reform, including recommendations in respect of the particular public authorities, for the development, improvement, modernization, reform or amendment to this Act or other legislation or common law or any other matter relevant for operationalising the right to access information.

The present Report is the first Annual Report to be prepared by the Meghalaya State Information Commission. While focusing is made on the legal requirements, useful information on the State machinery for enforcing the provisions of the Right to Information Law etc. have also been corporated as appendices to this Report, to the extent information could be obtained from the concerned public authorities.

The Commission will be very thankful for any suggestions to improve the form and contents of the Report in the public interest.

CHAPTER – 1

The Meghalaya State Information Commission – an over view:

1.1 Constitution of the Commission:

The Meghalaya State Information Commission was constituted by the State Government of Meghalaya on 3rd October, 2005 w.e.f. 30th July, 2005 vide Government Notification No. IPR.48/2005/PT.II/10 with its headquarters at Shillong, the State capital. The Notification was subsequently revised and the date of constitution of the Commission was w.e.f. 7th October, 2005 vide Notification No. IPR.48/2005/PT.II/11 Dated 7th October, 2005. The Commission, however, remains non-functional pending appointment of the Chief Information Commissioner.

On 20th February, 2006 the Government of Meghalaya vide Notification No. PER.42/2005/PT/48 appointed Shri G.P.Wahlang, IAS (Retd.) as State Chief Information Commissioner from the date of joining for the period of 5(five) years as required under the Right to Information Act, 2005. Shri G.P.Wahlang, IAS (Retd.) assumed charge of the office of the State Chief Information Commissioner on the 3rd March, 2006 (F.N.) after making/subscribing before His Excellency, the Governor of Meghalaya an oath or affirmation according to law.

The Meghalaya State Information Commission, till writing of this Report is a one-man Commission i.e. the Chief Information Commissioner is the only member, with the following address:

1.2 **Duties, Powers and Functions of the Commission:**

The duties, powers and functions of the State Information Commission have been spelt out “Under Sections 18, 19 & 20 and 25 of the Right to Information Act, 2005.

1.2 (i) **Receiving and enquiring into complaints:**

Under Section 18, it is the duty of the State Information Commission to receive and enquire into a complaint from any person, -

- (a) who has been unable to submit a request for information to a Public Information Officer of the State (PIO) either by reason that no such officer has been appointed under this Act, or because The Assistant Public Information Officer (APIO) under him has refused to accept his or her application for information or appeal under this Act for forwarding the same to the concerned Public Information Officer or senior officer specified in sub-section (l) of section 19 of the Act, or the State Information Commission, as the case may be;
- (b) who has been refused access to any information requested under this Act;
- (c) who has not been given a response to a request for information or access to information within the time limit specified under this Act;
- (d) who has been required to pay an amount of fee which he or she considers unreasonable;
- (e) who believes that he or she has been given incomplete, misleading or false information under this Act, and
- (f) in respect of any other matter relating to requesting or obtaining access to records under this Act.

If the Commission is satisfied that there are reasonable grounds to enquire into the matter, it may initiate an enquiry in respect of the complaint.

While enquiring into a complaint, the Commission has the same powers as are vested in a Civil Court while trying a suit under the Code of Civil Procedure, 1908, in respect of the following, matter, viz.,

- (a) summoning and enforcing the attendance of persons and compelling them to give oral or written evidence on oath and to produce the documents or things;
- (b) requiring the discovery and inspection of documents;
- (c) receiving evidence on affidavit;
- (d) requisitioning any public record or copies thereof from any court or office;

- (e) issuing summons for examination of witnesses or documents; and
- (f) any other matter which may be prescribed.

During the enquiry of any complaint under the Act the Commission may examine any records to which the Act applies which is under the control of the public authority and no such records may be withheld from it on any grounds notwithstanding anything inconsistent contained in any other Act of Parliament or State Legislature.

1.2.(ii) **Hearing appeals:**

Under Section 19 of the Act, the State Information Commission is duty bound to hear appeals preferred against the decisions made by the first Appellate Authority or Designated Appellate Authority on appeal against Orders of the Public Information Officers. While deciding such appeals (known as second appeals) against the decision of the Departmental Appellate Authority, the Commission has to prescribe its own procedure and its decision is binding.

In its decision the Information Commission has power to:

- (a) require the public authority to take any such steps as may be necessary to secure compliance with the provisions of the Act, which include -
 - (i) by providing access to information, if so requested, in a particular form;
 - (ii) by appointing a Public Information Officer;
 - (iii) by publishing certain information or categories of information;
 - (iv) by making necessary changes to its practices in relation to the maintenance, management and destruction of records;
 - (v) by enhancing the provision of training on the right to information for its officials;
 - (vi) by providing it with an annual report in compliance with clause (b) of sub-section (1) of section 4;
- (b) require the public authority to compensate the complainant for any loss or other detriment suffered;
- (c) impose any of the penalties provided under the Act;
- (d) reject the application.

The Information Commission has to give notice of its decision, including any right of appeal, to the complainant and the public authority.

1.2. (iii). **Imposing penalties:**

Under Section 20 of the Act, the Commission may also impose penalty on and/or recommend for disciplinary action against erring Public Information Officers.

- Where the State Information Commission, at the time of deciding any complaint or appeal is of the opinion that the Public Information Officer, has, without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was subject of the request or obstructed in any manner in furnishing the information, it has to impose a penalty of Rs.250/- each day till application is received or information is furnished subject to the total amount of such penalty not exceeding Rs.25,000;
- The Public Information Officer has to be given a reasonable opportunity of being heard by the Commission before any penalty is imposed on him or her;
- The burden of proving that a Public Information Officer acted reasonably and diligently shall be on the concerned Public Information Officer.
- Where the State Information Commission, at the time of deciding any complaint of appeal is of the opinion that the Public Information Officer, has, without any reasonable cause and persistently, failed to receive an application for information or has not furnished information within the time specified or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it has to recommend for disciplinary action against the Information Officer under the service rules applicable to him or her to the concern Public Authority or Department.

1.2. (iv) **Preparation of the Annual Report:**

Under Section 25 of the Right to Information Act, it is the duty of the State Information Commission to prepare an Annual Report on the implementation of the provisions of the Act during the year and submit the same to the appropriate Government. Such report shall state, in respect of the year to which it relates, –

- (h) the number of requests made to each public authority;
- (i) the number of decisions where applicants were not entitled to access to the documents pursuant to the requests, the provisions of this Act under which these decisions were made and the number of times such provisions were invoked;
- (j) the number of appeals referred to the State Information Commission, for review, the nature of the appeals and the outcome of the appeals;
- (k) particulars of any disciplinary action taken against any officer in respect of the administration of this Act;
- (l) the amount of charges collected by each public authority under this act;
- (m) any facts which indicate an effort by the public authorities to administer and implement the spirit and intention of this Act;
- (n) recommendations for reform, including recommendations in respect of the particular public authorities, for the development, improvement, modernization, reform or amendment to this Act or other legislation or common law or any other matter relevant for operationalising the right to access information.

From the above summary of the various provisions of the Law relating to the duties, powers and functions of the Information Commission, the Right to Information Act clearly placed a crucial responsibility on the Commission towards the establishment of the practical regime of Right to Information for citizens and promotion of transparency and accountability in the working of public authorities in the State. This role includes aspects of remedy, education, enforcement and guidance for reforms.

1.3 **Activities under taken by the Commission during the year, 2006:**

As has been stated, the Meghalaya State Information Commission became operational with effect from 3rd of March, 2006 with the assumption of duties by the Chief Information Commissioner. During a short span of time, the Commission tried its best to perform its duties and functions entrusted upon it by the law. As already

stated in the foregoing paragraph; the main duties and functions of the Commission are to dispose off complaint and appeals received by it. Statement 1.3 (I) gives in a nutshell, the number of such complains/appeals received and disposed off by the Commission during the year.

Besides the above statutory activities, the Commission has also to devote much of its time and attention towards establishment of a new office, viz., creation of posts, appointment of officers and staff, office accommodation and other immediate requirement for functioning of the Commission.

The Commission has been engaging itself with various institutions in the State in creating awareness of the Right to Information envisaged under the Act. 4(four) awareness campaigns organized by NGOs and Central Government establishments have been attended during the year and 2(two) programmes on Right to Information has also been participated as Resource Person.

Finding that many government departments/public authorities have not taken adequate steps in implementing provisions of the law especially in areas of management of records, Suo Motu disclosure of information and appointment of PIOs, the Commission had taken a number of meetings with the Heads of all Government Departments to review the implementation of the provisions of the law.

1.4 **Key issues facing the Commission:**

Some of the key issues which are engaging the attention of the Commission during the year are of the following:

(i) **Office accommodation for the Commission:**

As could be expected, office accommodation is one of the major issues engaging the attention of every new establishments. The same is true with the Meghalaya State Information Commission. Recently the State Government has agreed in principle to spare a few rooms in the newly constructed Administrative building at Lower Lachumiere, Shillong to accommodate the office of State Information Commission. The process of allotment is yet to be finalized by the State Government. The Commission is hopeful of the new accommodation.

(ii) **Appointment of PIOs and DAAs etc. by public authorities:**

As already stated at para 1.3 of the report, appointment of PIOs/DAAs by Public Authorities has also taken a good amount of efforts on the part of the Commission to rectify some of the defects. While some Government Departments like Education, Health etc. have taken appropriate steps to ensure that the system of dissemination of information is decentralized, some other institutions especially the Autonomous District Councils etc. of the State are yet to comply with the requirements of the Commission.

(iii) **Training:**

After the initial exposure of the senior officers of the Government following the passing of the Right to Information Act, 2005, there has not been any meaningful training imparted to the PIOs, APIOs, DAAs either by respective departments or by the Nodal Departments of the Government. As a result, many PIOs still fight shy of the implementation of the new law. Neither the matter of management of records nor the requirement of Suo Motu disclosure of information has been attended to with the seriousness it deserves, by the Government Departments and Public Authorities. These are matter of great concern to the Commission. The Commission will never get tired of playing its role to educate and guide public authorities and their designated officers to achieve the desired goal of good governance, which is principal focus to the new law.

(iv) **Awareness Campaign:**

There has not been any awareness campaigns conducted by the Government and its departments in the districts especially in the rural areas. The Nodal Departments is supposed to conduct such awareness campaigns especially at the district headquarters; but nothing happened during the year. As a result, public participation in the implementation of the law has not been as lively as expected. Credit goes to the Right to Information Movement, an NGOs of the State, who on their own, took initiatives of holding some awareness campaigns in Shillong and other district headquarters in Khasi and Jaintia Hills including a few Sub-Divisional and C.D. Block Headquarters. It will be our constant endeavour to see that every citizen of the State is aware of his right to information provided under the law.

1.5 Observations of the Commission:

Notwithstanding problems and difficulties faced by the Commission during the first year of its existence, it is the vision of the this Commission that all the citizens of the State nay of the country as a whole, including people living in the villages, should have access to information guaranteed to them by the law whenever they require. It is a well-known fact that the village authorities are also a repository of a vast amount of public information relating to law & order, revenue, developmental activities etc., which are very important to the citizen of the State. It is therefore, our firm believes that this information which is available with the village and local authorities should remain in the public domain in the general interest of the State and its people. Therefore, besides performing the statutory functions entrusted upon it by the law, this Commission will always play its role as a friend, philosopher and guide to the citizens in exercise of the right to information and to public authorities in the their discharge of their duties to make information accessible to the people.

CHAPTER – 2

Implementation of the Right to Information Act in the State:

In this Chapter, the Commission has tried to present an over view of the implementation of the Act at various levels. The key objective is to provide a status report on the action taken by various authorities to secure a practical regime of the Right to Information for citizens based on factual data pertaining to the year 2006. It may be noted that the implementation of the provisions of the Right to Information Act rests with Government Departments, Public Authorities, PIOs and of course with the State Information Commission. The Commission has therefore tried, as far as practicable, to present the status report separately for each activity required to be implemented by different authorities.

2.1 Management of Records:

Under Section 4(1) of the Act, every public authority is required maintain its records, duly catalogued and indexed in the manner and the form which facilitates the Right to Information under the Act and to ensure that all records that are appropriate to be computerized are, within reasonable time and subject to availability of resources, computerized and connected through network all over the country on different systems so that access to such records is facilitated.

The above important mandatory requirement does not seem to have receipt the attention it deserves from Government Departments and Public Authorities. Nothing has come to the knowledge of the Commission about any training imparted to the staff of various public authorities/departments on indexing and cataloging of records and no new initiative has been taken for development of management information system in Government offices. A few Government Departments have created their own Websites during the year but actual computerization of records does not seem to have received the full attention of the Departments and public authorities. The Commission had always emphasized on this important area all its review meetings with the Government Departments and public authorities.

2.2 Suo Motu Disclosure of information:

Section 4(1) (b) of the Act requires that the Government Departments/public authorities published 17 Manuals within 120 days from the date of enactment of the Right to Information Act and to update such information every year. In compliance

with the above provision of law, State Government Departments and public authorities have taken certain concrete steps and these are represented in the statement 2.2.(I) below.

2.5. Disposal of First Appeals by Designated Appellate Authorities:

Under Section 19(1) of the Act, any person who does not receive a decision within 30 days of the request made or is aggrieved by a decision of the Public Information Officer may within 30 days from the date of expiry of such period or from the date of receipt of such decision preferred an appeal to such officer who is senior in rank to the PIO in each Public Authority. This is the First Appeal against the decision or refusal of decision of the PIO. In this Reports the senior officer who received the First Appeal is referred to as Designated Appellate Authority (DAA). 2.6 Disposal of complaints by State Information Commission:

Under section 18(1) &(2) of the Right to Information Act, it is the duty of the State Information Commission to receive and enquire into a complaint from any person who has been unable to submit a request to a PIO or because PIO/APIO has refused to accept his or her application for information or appeal or who has been refused to forward the request to the PIOs or who has refused access to an information requested or who has not been given a response to a request for information within the time limit specified by the law or who has been required to pay an amount of fee which he or she considered unreasonable or who believes that he or she has been given incomplete, misleading or false information. The statement 2.6.(I) below gives an account of the complaints received by the Commission and their disposal or

2.8 Action Against Erring Officials:

During the year the Commission did not impose any penalty under Section 20(1) of the Act and also did not recommend any disciplinary action under section 20(2).

2.9 Fees and charges collected:

Section 4(4) of the Act empowers Public Information Officers to collect the cost of the medium, the printed cost price of materials supplied to the requesters if the person is not below the poverty line category. Section 6(1) of the Right to Information Act, empowers the Public Information Officers to receive the application fee as prescribed under rules framed by the Government. Section 7(1) empowers the Public Information Officers to provide the information on payment of such fees as prescribed by the Government. Section 7(5) empowers the Public Information Officers to collect the fees as prescribed for supplying of the information in the printed form or any electronic format. CHAPTER – 3

Key Issues and challenges:

5. The Annual Report of the State Information Commission is not expected to limit its scope only to the activities under taken by the Commission itself; but to also cover all areas of operation of the law. The Commission has therefore to adopt a holistic approach while making the report, linking with areas that are concerned with roles and functions required to be played by the appropriate Government Department/competent authorities and their public authorities and other functionaries designated under the law. With this aim in view, this Chapter tries to focus on some key issues and challenges, which the Commission considered important to highlight with a view to bringing about improvement in the implementation of the law.

5.1 Creating an enabling environment:

Section 26 of the law, requires certain activities on the part of the appropriate Government/competent authorities, to create an enabling environment for successful implementation of the law. These includes the following -

- (a) Developing and organizing educational programmes to advance the understanding of R.T.I. in particular among the disadvantaged communities as to how to exercise their entitlement right under the Right to Information Act.
- (b) Encouraging public authorities to participate in and to undertake themselves educational programmes on the Right to Information,
- (c) Promoting timely and effective dissemination of accurate information by public authorities about their activities; and
- (d) Training Public Information Officers and producing relevant training materials for use by the public authorities themselves.
- (e) Compilation of guidebook in the official language of the State containing such information, in an easy and comprehensible form and manner as may reasonably be required by a person who wishes to exercise any right specified in the Act, and to update and publish such guidelines at regular intervals.

- 5.1.1 Certain guidelines have been prepared by the nodal Department of Government during 2005, immediately after the law came into force. There has not been any revision or updating of such guidelines and they have not been published in the associated official languages of the State viz., the Khasi and the Garo as yet. Absence of comprehensive guidelines especially in the associated official languages of the State spoken and understood by the majority of the people, has limited the extent of appreciation of the new law among the people of the State especially those living in the rural areas.
- 5.1.2 During the year 2006, no public education efforts and mass awareness campaigns have been conducted by the appropriate Government. This has again denied the State of creating a conducive environment for the implementation of the Act.
- 5.1.3 Besides the above, there are also certain legal and institutional bottlenecks which act adversely in creating the right environment for implementation of the law especially in the rural areas. The **Panchayati Raj Act**, is not applicable to the State of Meghalaya. However the State has three Autonomous District Areas under the three Autonomous District Councils, viz., the Khasi Hills Autonomous District Council, the Garo Hills Autonomous District Council, and the Jaintia Hills Autonomous District Council, created under the Sixth Schedule to the Constitution. Though the areas of jurisdiction of the Councils extend over the whole of the Autonomous Areas; yet, there are no effective legal/institutional linkages between the Autonomous District Councils or their public authorities with the Village authorities; thereby, posing certain discomforts in the implementation of the law.
- 5.1.4 The law did not specifically provide for any institutional arrangement for coordination, monitoring, review and evaluation of the implementation of the law. With the progress of implementation, it is genuinely felt that there should be a State-level Coordinating Body consisting the appropriate Government, the competent authority and the Information Commission to remove bottlenecks and to facilitate smooth progress implementation of the Law.

5.2 **Operationalization and Enforcement of the Act:**

5.2.1 **Creation of appropriate machinery for implementing the law:**

Under the Right to Information Act, the Public Information Officer plays a very

vital role for operationalisation of the law. Various Departments and public authorities have initially designated PIOs, APIOs, AOs and Appellate Officers in their respective public authorities/Departments. The Commission had during the year reviewed the steps already taken by each Department/Public Authorities on this matter and many changes and improvement have been introduced subsequently. The list of PIOs, APIOs and DAAs designated by public authorities however lacks the basic information including correct addresses, contact numbers, and area/type of information available with the PIOs etc. In addition there is no combine directory of all PIOs, APIOs, DAAs etc. in the State. These omissions have adversely affected the smooth implementation and operationalisation of the new law and should be removed.

- 5.2.2 Another vital area which remained almost unattended after the implementation of the law is the management of records and information system within the public authorities themselves. From the cases which came up before it by way of complaints, the Commission observed that the general delay in supplying information to the requestors is caused by the fact that records are not readily available with the PIOs. Searching for the records has been the main plea for delay. Government Departments and Public Authorities could ill afford to neglect this important area any longer; otherwise, they will have to spend unnecessarily a lot of working hours and manpower in locating information which will adversely affect the efficiency of their performance in their normal works, besides incurring penalty for delay in supplying the information.
- 5.2.3 Under section 4(b) of the law, Pro-active Disclosure of Information by public authorities is an important steps in operationalisation of the new law. Some manuals have been prepared by the public authority at the initial stage and are made available to the PIOs. However, such manuals need revision and updating at regular intervals. During the last one year such revision or updating of manuals by Public Authorities/Government Departments have not come to the notice of the Commission.
- 5.2.4 As has been stated, the PIOs play a vital role in operationalisation and enforcement of the new law. During the year no such specific training or sensitization programme have been organized by the Government/public

authorities for the PIOs, APIOs, and other functionaries under the Right to Information Act. As a result, many PIOs remained uncomfortable in handling requestors for information. Some of them waited for the Orders of higher authorities whether or not to supply the information; whereas under the law, the PIO is an independent authority and should perform his duties under the law as such independent authority. If there has been any success in the operationalisation and enforcement of the new law in the State during the last one year, the credit for it should go to the efforts made by the NGOs/community groups who on their own had taken up public sensitization programmes in some areas of the State. What is required is encouragement and support to these NGOs or Community groups to take up awareness campaigns in all part of the State, in a regular manner.

It is advisable that all Government Departments of the State Government and other Institutions should take up monitoring review and evaluation of implementation of the Right to Information Act at their levels. This is urgently required especially in the critical area of records management and information system for smooth operationalization of the law.

5.3.1 **Effective implementation of the Right to Information Act:**

5.3.2 Effective implementation of the Right to Information Act is by itself, a great administrative challenge. The process of seeking information starts with filing of a request by a citizen. Once a request is filed, the onus of responding to the request rests with the public authorities and its functionaries. A complaint that is regularly received in the Commission relates to non-availability of the list of public authorities and their functionaries. It is expected that the Nodal Department of the Government should prepare a comprehensive list of all public authorities including the DAAs/PIOs/APIOs and other officers for each and every Departments of the Government for ready reference and update it from time to time. However, such a compilation is yet to be brought out in a complete and correct form. Even the Departments themselves have to review the list of their public authorities and functionaries from time to time and the lists are to be published by them at the first instance. For citizens to access information, a catalogued or indexed list of all functionaries appointed or designated under the law is necessary. As a supplement to

this deficiency, the Commission is including one annexure containing the list of DAAs/PIOs/APIOs & Public Authorities in this Annual Report.

- 5.3.3 Many PIOs and APIOs of public authorities are located at the district and the sub-divisional headquarters. The offices of different Departments are often disperse in various locations at each district headquarters. Sometime, citizens are not aware of their locations and it become difficult for an applicant to identify the correct PIOs/APIOs and to locate it. As a result, many of them run to the state headquarters and to the Commission for information. This has been one of the major problem areas in effective implementation of the law in the State.
- 5.3.4 During the last one year a good amount of information has been carried in the media on various aspect of the Right to Information Act and its implementation. Despite this, the Commission feels that the level of awareness especially at the grass root level is still very low in the State. In order to implement the Act effectively it is necessary for the citizens to become aware of their entitlement and also the process involved to access information and to improve the quality of governance. An effective public awareness campaign involving voluntary organizations/NGOs/community groups is a must, not only for effective implementation of the law but for empowerment of the people themselves which the law aims at.

CHAPTER – 4

Observations & Recommendations of the State Information Commission:

6.1 Section 25(g) of the Right to Information Act requires that the State Information Commission make necessary recommendations for reforms in the annual report, for the development, improvement, modernization, reforms or amendments to the Act or other legislations or common laws or any other matter relevant for operationalising the right to access information.

Being the first year of operation of the law and during a short period of working, the Commission is yet to gain adequate experience in the implementation of the Right to Information Act. However, with a limited experience gained during the period, the Commission did come across certain areas of inadequacies and deficiencies in certain aspects of the law, its operationalisation and implementation. Some of these observations together with appropriate recommendations to the concerned authorities are presented below:

6.2. Legal and Institutional Changes:

6.2.1 **Observations: 1**

- (i) Section 19(8) of the Right to Information Act states that “ in its decision,” the State Information Commission has the power to –
 - (a) require the public authority to take any such steps as may be necessary to secure compliance with the provisions of this Act, including –
 - (i) by providing access to information, if so requested, in a particular form;
 - (ii) by appointing a State Public Information Officer, as the case may be;
 - (iii) by publishing certain information or categories of information;
 - (iv) by making necessary changes to its practices in relation to the maintenance, management and destruction of records;
 - (v) by enhancing the provision of training on the right to information for its officials;
 - (vi) by providing it with an annual report in compliance with clause (b) of sub-section (1) of section 4;

(b) require the public authority to compensate the complainant for any loss or other detriment suffered;

(c) impose any of the penalties provided under this Act.

The law however, does not provide any remedy for refusal on the part of the public authority/PIO to carry out any decision of the Commission though under section 19(7) it is provided that “the decision of the State Information Commission shall be binding”. This is one of the areas of weakness of the law that leaves the Commission almost powerless to deal with any such un-cooperative elements. For example, under section 19(8)(b) the Act, empowers the Commission to require the public authority to compensate the complainant for any loss or other detriment suffered. However, there is no provision through which the Commission has to enforce such directions/Orders. The same is also true in the case of penalties as provided under section 19 (8) (c) of the Act

6.2.2 **Recommendation: 1**

There should be a penalty clause for failure to carry out any decision of the Commission. This may be done by adding the following words in sub-section(1) of Section 20 in between the words “**or obstructed in any manner in furnishing the information**” and the words “**it shall impose penalty of Rs.250/- each day etc.**” namely;

“or refused to carry out any decision of the Central Information Commission or, the State Information Commission under Section 19(8) (a) & (b)

The above same words may added in Sub Section (2) of Section 20 after the word “**or obstructed in any manner in furnishing the information**” and the word “**it shall recommend for disciplinary action**”.

6.2.3 **Recommendation: 2**

In order to enable the Commission to enforce its Orders on imposing of penalty and payment of compensation under section 19 (b) & (c) of the Act, it is necessary that the law be amended or a definite procedure be laid down for realizing the amount of penalty/compensation imposed whenever public authorities/PIOs refused to carryout the decisions of the Commission. One way of doing this is to consider that such amount of penalties/compensation shall be deemed to be a public demand as defined under section 3 of the Bengal Public Demands Recovery Act, 1913.

6.2.4 **Observations:** 2

It is the vision of this Commission that all the citizens of the State including people living in the villages should have access to information effecting their life and well being whenever they required. It is a well known fact that the village authorities in the State is the repository of a vast amount of public information relating to law & order, revenue and developmental activities which are very important to the citizens of the State. It is therefore, our firm believe that this information which is available with the village and local authorities should remain in the public domain in the general interest of the people of the State as a whole. The Commission however observed, from the cases brought before it that there are very weak linkages between the State Government or the Autonomous District Councils with the local village authorities. The fact that the Panchayat institutions as provided under Part IX of the Constitution of India, does not apply to the State, leaves the problem untouched. What is required is a favourable legal/administrative linkages between the State Government or the Autonomous District Councils with the local durbars at the village level. The Autonomous District Councils of the State should have made laws under Para 3(1)(e) of the Sixth Schedule of the Constitution for establishment of village Committees/Councils and define their powers, to bring the local authorities within the ambit of its administration.

6.2.5 **Recommendation:** 3

It is recommended that the three Autonomous District Councils of the State make necessary laws as provided under Para 3(1)(e) of the Sixth Schedule to the Constitution of India.

6.2 **Systematic Reforms:**

6.2.1 **Observations:** 3

After the Right to Information comes into operation, there has not been any visible attempt on the part of the Government and its departments to introduce any reforms to the existing system of management of official records. Therefore, records-maintenance and records keeping, if any, whatsoever, in existence today are being done in accordance with the existing rules and instructions of the Government. The same is true with regards to the length of time for safe-keeping of records and their

destruction etc. in spite of the fact that Section 8(3) of the Right to Information Act clearly stated that any information relating to any occurrence, events or any matter which is taken place, occurred or happened twenty years before the date of which any request is made shall be provided to any person making the request. Even computerization and networking has not made much head way among government departments and other public authorities and institutions outside the Government. It may be possible that capability in government departments is limited to undertake reforms in the system of records management and also in computerization and networking.

6.3.2 **Recommendation:** 4

It is therefore, recommended that the Government in the Administrative Reforms Department engaged a competent Consultant to study the existing system of Record Management and Record Computerization and to advise necessary reform in the system, in keeping with the mandatory reforms and the time.

6.3 **Operationalisation and Enforcement:**

6.4.1 **Observations:** 4

As stated in the report a lot of complaints have come before the Commission about non-availability of a directory of public authorities/PIOs, APIOs, and Appellate Authorities. This has placed the information seekers in a very difficult position as they have to run from pillar to post to get to know the correct authorities/PIOs to whom they should file the requests. Many of them turned to the Commission for queries and even for submission of requests.

6.4.2 **Recommendation:** 5

This problem should be removed forthwith and a Directory of Public Authorities/PIOs, APIOs and Appellate Authorities be compiled immediately by the nodal department and be updated regularly. Every public authorities should have a copy of each and extra copies be kept in the office of every Deputy Commissioners and Sub-Divisional Officers for ready reference by interested citizens.

6.4.3 **Observations:** 5

As mentioned in the report, the Act did not prescribe any institutional mechanism for coordination, monitoring and review within the appropriate government/institutions.

The Commission on its own initiative has taken up certain activities for coordinating and reviewing the operationalisation and enforcement of the law with concerned public authorities/PIOs etc.

6.4.4 **Recommendation:** 6

It is therefore, recommended that there should be a Standing Committee to be chaired by the Chief Secretary with the Heads of all government departments so as to provide a forum for coordination, monitoring and review on the implementation of the law and of course the necessary reforms.

Alternatively, government may authorize the State Information Commission to undertake such activities on the regular basis.

6.4.5 **Observation:** 6

Support to the State Information Commission:

The Right to Information Act mandates a legal – institutional framework for setting out a practical regime of Right to Information for every citizens to secure access to information held by or under the control of public authorities. Basing on the experience gained during the first one year of operation of the law, it is the view of this Commission that only a few educated people have been able to get access to information that too, not without difficulties. In the way things stand today, it is difficult for the people at large especially the rural poor to exercise their rights to information. Apart from lack of awareness of the provisions of the law, it is the diverse location of the offices of the PIOs/APIOs and authorities that posed a hindrance to the general citizens to submit their requests for information. In order that all citizens should have access to information as guaranteed by the law, it is necessary that they should be enable to exercise their rights to information.

6.5.6 **Recommendation:** 7

It is therefore, recommended that the State Information Commission should have a Cell attached to the office of the Deputy Commissioner in each district. This Cell with a skeleton staff will serve as a Single Window Agency which would receive requests for information on behalf of the public authorities/PIOs which have their jurisdiction in the concerned district and then forward them to their respective public authorities/PIOs. This, apart from helping the public, would also help in keeping track of their applications. If the system proved effective it may be extend to the

Sub-Divisional Headquarters also.

6.6 **Pro-active disclosure and transparency:**

6.6.1 **Observation:** 7

In compliance with the provision of Section 4(1)(b) of the Right to Information Act, most of the departments of the State Government brought out their respective manuals covering by and large the 16 categories of information as listed therein. It is however, observed that none of these manuals have been updated even after a lapse of one year from the date they were first made. Besides, the law requires publication of relevant facts while formulating important policies, for announcing the decisions which affect the public with proper reasons in respect of administrative or quasi judicial decisions to the persons affected. Nothing has come to the notice of the Commission of such action being taken by any Departments of the State Government.

6.6.2 **Recommendation:** 8

It is therefore, recommended that all Government Departments update their publications and make them available to the public as priced publications. They should also take steps to publish relevant facts and policy decisions which affect the public with due reasons thereof.

6.6.3 **Observation:** 8

While making its observation on this important aspects of the Right to Information Act, the Commission also observed with satisfaction Sou Motu disclosure of information made by the MLA of 21 Mawprem Assembly Constituency in the form of a Booklet listing all schemes (physical and financial) taken up by him in his Constituency under the MLA Scheme during the year 2004-2005 & 2005-2006.

6.6.4 **Recommendation:** 9

The Commission recommends that Government should make it obligatory on the part of the implementing agencies to prepare and publish the list of all the schemes (physical and financial) implemented under MLA Scheme during the year, constituency-wise. The same should also be done with respect to MPLADS.

6.7 **Capacity building and training:**

6.7.1 **Observation:** 9

As stated in the earlier Chapters of this report there has not been any worthwhile

training imparted to the PIOs/APIOs/DAAs during the year. And, there has not been any capacity building measure at any level under-taken so far, either by the Government or by the public authorities themselves. There is no activities under taken by the Government to generate awareness among the general public on the Right to Information Act after its enforcement in the State. These are serious drawbacks in the smooth operationalisation and enforcement of the Act.

6.7.2 **Recommendation:** 10

It is therefore, recommended that all PIOs/APIOs/DAAs and other senior Government functionaries at the State level and district headquarters should be imparted at least one day training on Right to Information every year. Awareness campaign may be entrusted to credible NGOs and necessary funds be earmarked as grant-in-aid to those NGOs.

6.7.3 **Recommendation:** 11

15th October, 2005 the date on which the Right to Information Act was made operational should be celebrated as a Right to Information Day. The celebration should include awareness campaign, training activities etc. on Right to Information at various district headquarters of the State by Government and NGOs as well.

6.8 **Role of Civil Societies:**

6.8.1 **Observation:** 12

As already mentioned in the earlier Chapters of this report certain initiative had been taken by some NGOs of the State in creating awareness among the public especially, in the Khasi – Jaintia region of the State. However, the initiative was limited only in district headquarters and a few centers outside the district headquarters.

6.8.2 **Recommendation:** 12

In order to enable the Civil Society Organisations/NGOs to sustain their initiative in their public education efforts and mass awareness generation on Right to Information it is recommended that State Government provides necessary support to them in the form of grant-in-aid. Necessary provision may be made in the budget of the Nodal Department.
